This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The board of directors (the “Board”) of Great Eagle Holdings Limited (the “Company”) announces that on 14 March 2019 (the “Date of Grant”), 5,673,000 share options (the “Option(s)”) to subscribe for ordinary shares of HK\$0.50 each (the “Share(s)”) of the Company were granted, subject to acceptance of the grantees, under the Company’s Share Option Scheme adopted on 27 May 2009.
